Reference is made to (i) the five (5)% per annum coupon rate convertible note in the principal amount of HK\$209,000,000 issued on 20 February 2023 to the Noteholder by the Company (the "2023 Convertible Note"); (ii) the deed of amendment dated 23 January 2024 entered into between the Noteholder and the Company whereas the transaction of which was completed on 17 April 2024; and (iii) the revised 2023 Convertible Note issued on 17 April 2024 to the Noteholder by the Company. Unless otherwise defined, terms defined herein shall have the same meanings as those defined under the 2023 Convertible Note (as revised on 17 April 2024).

We, the Noteholder, irrevocably undertake that we will not exercise our conversion rights to convert the 2023 Convertible Note (or any part thereof in authorized denomination) into Conversion Shares or transfer the 2023 Convertible Note before the record date of the proposed issue of the rights shares of the Company (details of which are set out in the announcement issued by the Company on 15 October 2024).
