CHANGE OF COMPANY NAME, STOCK SHORT NAMES, COMPANY LOGO AND COMPANY WEBSITE

References are made to (i) the announcement of Asset Chain Limited (formerly known as Eminence Enterprise Limited) (the “**Company**”) dated 19 January 2026 (the “**Announcement**”); (ii) the circular of the Company dated 20 January 2026 (the “**Circular**”); and (iii) the poll results announcement of the Company dated 9 February 2026 in relation to, among others, the Further Proposed Change of Company Name. Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

As stated in the Announcement and the poll results announcement of the Company dated 6 January 2026, the change of the English name of the Company from “Eminence Enterprise Limited” to “Smart Chain Company Limited” and the adoption of the Chinese name “財富鏈有限公司” as its new secondary name to replace its then Chinese name “高山企業有限公司” has been approved by the Shareholders at the special general meeting of the Company held on 6 January 2026 and became effective on 6 January 2026 when the Certificate of Change of Name and the Certificate of Secondary Name were issued by the Registrar of Companies in Bermuda. Subsequently, it is further proposed to change the English name of the Company from “Smart Chain Company Limited” to “Asset Chain Limited” and the Chinese name “財富鏈有限公司” will remain the same as the secondary name of the Company.

The Board is pleased to announce that following the passing of a special resolution approving the Further Proposed Change of Company Name by the Shareholders at the SGM held on 9 February 2026, the Certificate of Change of Name and the Certificate of Secondary Name were issued by the Registrar of Companies in Bermuda certifying that the English name of the Company has been changed from “Smart Chain Company Limited” to “Asset Chain Limited”, and the Chinese name of “財富鏈有限公司” has been registered as the secondary name of the Company, and the new names have been entered into the register maintained by the Registrar of Companies in Bermuda with effect from 9 February 2026.

The Registrar of Companies in Hong Kong issued two Certificates of Registration of Alteration of Name of Registered Non-Hong Kong Company under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong). The first certificate, issued on 26 February 2026, confirmed the registration of the English name of the Company was changed from “Eminence Enterprise Limited” to “Smart Chain Company Limited” and its Chinese name was changed from “高山企業有限公司” to “財富鏈有限公司”. Subsequently, the second certificate issued on 27 February 2026 confirmed the registration of the further change of the English name of the Company from “Smart Chain Company Limited” to “Asset Chain Limited” and its Chinese name “財富鏈有限公司” remains unchanged.

CHANGE OF STOCK SHORT NAMES

Following the change of company name becoming effective, the stock short name of the Company will be changed from “EMINENCE ENT” in English and “高山企業” in Chinese to “ASSET CHAIN” in English and “財富鏈” in Chinese, for trading in the Shares on the Stock Exchange with effect from 9:00 a.m. on 11 March 2026. The stock code of the Company on the Stock Exchange will remain unchanged as “616”.

EFFECT OF CHANGE OF COMPANY NAME AND STOCK SHORT NAMES

The change of the name and the stock short names of the Company will not affect the rights of the Shareholders or the daily business operations of the Group or its financial position. All the existing share certificates of the Company in issue bearing the former name of the Company will continue to be effective and as documents of title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates bearing the new name of the Company. All new share certificates of the Company will be issued in the new name of the Company in any subsequent issue of Shares.

CHANGE OF COMPANY LOGO

With effect from 6 March 2026, the Company has adopted a new logo, as shown on the top of this announcement, to reflect the change of company name.

CHANGE OF COMPANY WEBSITE

The Board also hereby announces that the website address of the Company will be changed from “www.eminence-enterprise.com” to “www.assetchain.com.hk” with effect from 11 March 2026.
